Population growth and changing economic dynamics are widely predicted, including a highly anticipated impact on the availability of affordable housing throughout Franklin County and this region. Anticipated changes to our community's economic and demographic landscape require thoughtful and intentional planning for a future that promotes community wellbeing and housing equity, mitigates structural disparities and ensures residents countywide have access to safe, quality, affordable homes.

Community Shelter Board (CSB) is proud to partner with the community, along with the City of Columbus, Franklin County, and the Columbus Partnership, to lead a coordinated process focused on solutions rightly aligned to the changing needs of diverse communities. The Comprehensive Community Assessment will include diverse perspectives and voices, provider organizations, and community stakeholders to assess the current state in Franklin County and chart a path responsive to our community's values and identity.

PURPOSE

- Build understanding of how housing and homelessness response systems work.
- Build understanding of anticipated economic and demographic changes affecting our response to homelessness and the housing market in Central Ohio.
- Disrupt current systems that exacerbate disparities.
- Above all, develop solutions that promote community wellbeing and fairness for all, advance racial equity, and ensure residents countywide have access to safe, decent, affordable homes.

EXPERTISE

CSB has hired Focus Strategies, a national consulting firm, to lead the analytic process. They will assess a series of data, processes, and policy. Analyses will inform our conversations and craft recommendations tailored to our community. We will test the feasibility of potential solutions and make real decisions about how to move forward together, as a community.
